Miami Operations

- Revised Smelter Turnaround schedule
 - Original schedule July 10 to July 31 (21 days)
 - Revised start June 30 to July 29 (29 days)
- Extended turnaround caused by major transformer failure on June 28
 - Transformer replacement precluded a practical smelter restart
- Contractors mobilized and started July 5
- Major turnaround scope items
 - Reline ISA vessel
 - Replace lower 18 feet of ISA hood
 - Re-brick large sections of electric furnace
 - Screen and replace catalyst in 1st pass of acid plant converter
 - Replace acid plant #1 Hot Gas Fan
 - Replace converter aisle 75-ton crane transverse bracing with upgraded design
 - Oxygen plant main air compressor maintenance
 - Reline both anode vessels
 - Install newly designed mouth and vent port required for Environmental Project

Community Engagement Update

The [Mini-Grants for Education](#) application deadline is October 1st. These classroom grants are designed to support K-12 teachers and schools in Freeport-McMoRan communities.

For the fourth consecutive year, Freeport-McMoRan has been named to the Civic 50 list of most community-minded companies in the U.S., and this year also was named the top company in the materials sector!
