- Pinal Valley Soil Program Freeport-McMoRan Miami Inc. is starting a voluntary soil remediation project this year. The project is under the Arizona Department of Environmental Quality's Voluntary Remediation Program. We will be investigating soil on properties located in Claypool and the western portion of Globe. The project will inform and engage the community through flyers, open house events and other forms of communication mid to late 2024.

Arizona Operations HRIA (Human Rights Impact Assessment) Debrief

- We conduct Human Rights Impact Assessments (HRIAs) as part of our commitment to
 operating in a way that respects people. HRIAs are both a <u>Human Rights Policy</u> commitment
 and a requirement of the Responsible Production Frameworks.
- As a follow-up to the Arizona operations HRIA completed in 2022, we provided an overview of our <u>HRIA process</u> as well as community-related findings and associated action items, soliciting feedback and input from CPP members. Key findings specific to Miami related to road safety, housing, pollution mitigation and communication.

In April 2023, Miami employees partnered with the Salvation Army Globe Service Extension Office to transition their daycare program to a food pantry. Community Feedback

The CPP serves as a resource to share company updates, but just as importantly, it serves to solicit input from communities related to concerns, opportunities and local priorities.

- **Question from CPP member:** What is the plan to support mining education and careers for 7-12 grade students?
 - Response: Historically, Freeport sent professionals into classrooms, with safety education and later mining education. We need to set up systems to enhance engagement and get the word out about existing programs like <u>Dig into Mining</u>. We support trades programs and have a strong partnership with the Regional Training Center for the welding program. The trainers from the program are also Freeport employees who provide classroom and community outreach about the importance of trades careers and local training opportunities. We will continue this conversation to match company resources with community interest and needs.
