

Operations Update

Tyrone:

- Achieved 294 days without a reportable injury, until early March
- Kicked off Tyrone's site vision titled, 'Expedition 100 million' which focuses on leaching efforts
- Current life of mine is through the end of 2027

Chino:

- Achieved 102 days without a reportable injury, until early March
- Life of mine is 2042 based on current copper price
- Continuing to invest in Chino's rebuild
- Completed first sag mill rebuild in 2023
- Second sag rebuild will begin April 1 and will take about 120 days to complete
- Expanding SX/EW facility

Organizational Changes
