Bagdad Q2 Update

- Continuing to focus on safety
- Slightly under copper production goals for the quarter and exceeded quarterly molybdenum production goals
- Solid unit cost and generated cash for the organization
- Collaboration with Yavapai County on Lindahl Road upgrade was successful and is now completed
- Improvements around town from the bleachers at the fields, to the updates to fitness center and community campus conference room are all signs of the work being done to enhance quality of life

## Townsite Update

There is a shortage of temp housing and motel rooms due to all the new hires. Housing is working closely with customers to keep everyone informed.

The Aquatic Center is starting private swim lessons for any age; contact the pool for information or to schedule.

There are improvements at the campus with upgrades to the conference rooms, office, fitness center, and pool entrance. The townsite is also undergoing improvements with new signage and kiosk to help with accessibility in town.

Townsite has recently started a business coalition meeting with groups in Bagdad. All business owners are invited to participate to share information, ideas and suggestions for running a business in Bagdad.

Access to Coors Lake is now closed. The state needed access to the road near the lake to finish work they have been doing over the past year which meant the gate may have been unlocked sometimes over the past few months. That work is complete and the area is now permanently closed.

### **Business Topic: Learning Circles**

As part of the Bagdad operations vision and mission statements the site is inviting departments and groups to hold gatherings called Learning Circles. These meetings are designed to be led by employees and provide an opportunity for employees to discuss business topics like leadership, and working with different generations. It is also a way to build trust and communication.

### **Community Engagement Update**

The community survey is complete with over 700 responses! Thank you to everyone for providing feedback and encouraging neighbors and friends to participate. Survey results are being compiled by our survey provider. We anticipate having them to share in the beginning of July.

**Q:** How will the results be communicated to the community, not just employees?

**A:** We commit to ensuring they are shared in a timely way with the community. There are a variety of ways we can do this using existing communication resources and we are evaluating what options will be most effective.

There is a new emergency notification system (EASE) which allows employees to receive urgent updates related to the site even if they do not have a company phone. All employees are encouraged to update their contact information online.

Temporary summer positions are being reviewed and we anticipate posting openings before the end of May. Bagdad operations is also currently hiring for full-time positions. All postings are on [fmjobs.com](http://fmjobs.com).
