#### Community Engagement Update

Each year Freeport-McMoRan partners with **United Way** to ensure that a range of charitable health and human service organizations — in addition to the ones employees support — have the financial resources to provide critical services to those in need. The Company’s 2016 campaign will run from **October 28 through November 18**. To enhance employee donations, the Freeport-McMoRan Foundation will double match the first \$1,000 donated and single match any amount above \$1,000 to United Way.

The Freeport-McMoRan Foundation is proud to partner with the Boy and Girl Scouts near our operations. In 2016, **\$30,000** was invested with local councils to support personal development, leadership experiences, financial literacy, STEM, community service and outdoor activities, etc.

## **Bagdad Strategic Plan**

As previously discussed, the plan is being shared with community members through the Community Partnership Panel, meetings with stakeholders and other public meetings. Our mission: Investing in our people for a better tomorrow. Our vision: We are Bagdad, where everyone is a leader. We help each other succeed and we promote the well-being of people and our community.

There are community components and opportunities to be involved, including a new team called the Bagdad Cohort. The Cohort will be a community based group determining and working toward an outcome to **promote lifelong learning in Bagdad**. The Cohort will receive leadership support from ASU Lodestar and the [Leadership Initiative for Sustainable Communities](#). Interested community members can apply by November 4. Community members who want to be involved, but have missed the deadline or cannot make the full time commitment to be on the Cohort, still have opportunities to be involved.
