**August 4, 2016**

### **Purpose**

The [Community Partnership Panel](#) is hosted by Freeport-McMoRan to keep the community informed about operational activities and to foster open and ongoing dialogue to develop thoughtful solutions to address community issues.

### **Safety Share**

### **Colorado Operations**

Henderson Operations headcount/actual	310/340
Climax Operations headcount/actual	385/416

- Henderson is using 'recall' process to backfill open positions.
- Scoping studies for Henderson closure are ongoing.

**Question:** Do you anticipate headcount in any capacity until possibly 2018. With the anticipated tax savings that the county granted to you, do you anticipate putting a portion of those savings into non-profits?

**Response:** No significant changes in employment levels are being considered while Henderson is operating at its current rate of production.

Our Colorado operations pay taxes on land, equipment and production. The taxes on production were averaged using a rate from when we were not only producing more but also getting a higher price. We were granted a reasonable adjustment by Grand County in the calculation method which gives us some tax relief over the next few years. The revised tax calculation better reflects the economic realities facing Henderson at its significantly reduced production level, helping to reduce unit operating costs which is critical to Henderson as we work our way through these difficult markets.

We are working hard to remain successful as long as possible, and continue to contribute to the long-term sustainability of the County through employment, sourcing from local businesses, tax payments and numerous social investment programs.

We encourage members of the local communities to continue to develop strong projects to promote sustainability and to submit those projects to us for funding opportunities.

### **Community Engagement Update**

The [Mini-Grants for Education](#) application deadline is **October 1<sup>st</sup>**. These classroom grants are designed to support K-12 teachers and schools in Freeport-McMoRan communities.

For the fourth consecutive year, Freeport-McMoRan has been named to the Civic 50 list of most community-minded companies in the U.S., and this year also was named the top company in the materials sector!

### **United Way**

Total [Henderson Operations](#) company double-match was \$106,311.

- \$8,504 (10%) to support Mile High United Way 211 system
  - Mile High United Way's 2-1-1 is a free and confidential community referral service that connects callers with resources which provide food, shelter, rent assistance, clothing, child care options and other types of community assistance. Trained referral specialists are multi-lingual and available to help individuals with real-time resources in our community.
- \$12,757 (15%) to support Mile High United Way Impact Fund
  - Gifts to the Impact Fund support the work of United Way and our Impact partners — select nonprofit organizations delivering measurable results in the areas of Education, Income, Health and Basic Needs — to help our most vulnerable neighbors break the cycle of poverty.

- We negotiate with Mile High United Way to bring the remaining 75% (\$85,049.00) of those dollars directly back to communities in our operating area.
