Operations Update



- Efforts are underway to enhance copper extraction from leach stockpiles, aiming to improve efficiency and reduce costs.
- At Sierrita, the mill processes about 110,000 tons daily
- As part of Freeport's overall decarbonization strategy, Sierrita was selected as a test site for Caterpillar battery electric haul truck early learner program.
- A Freeport Connects communication was shared with community members updating them about upcoming Demetrie Wash project updates. As a reminder, this work will adjust the alignment to support permit requirements for our mine operations.
- Sierrita is committed to continued leadership development for our employees. Recently, the site sponsored several leaders/influencers to attend the Echelon Front Extreme Ownership Women's Assembly.

Tailings Update

South Berm push on track to complete by end of 2024

- North Berm push to start toward end of Q1 2025 and is expected to take several months to complete.
- In Q3, we experienced strong isolated storms over the tailings facility creating challenges in managing our dust emission control. These storms created conditions that required manual applications of dust suppressant which our team was successful in applying.

Copper Mark Certification

The Copper Mark is a comprehensive assurance framework that promotes responsible production practices and demonstrates the industry's contribution to the United Nations Sustainable Development Goals (SDGs).

In August, Sierrita underwent an extensive audit for Copper and Moly Mark Certification. We are
pleased to report that as of November 2024 Sierrita has received recertification via Ernst &
Young of both the Copper Mark and Molybdenum Mark.

Biodiversity Update

Bat Week is an annual celebration of bats during the weeks leading up to Halloween. Bat-focused activities take place across the United States and Canada, both in person, and online through social media. Find out more at batweek.org.

Sierrita employees and community members from Green Valley and Sahuarita, along with Bat Conservation International and Pima County Invasive Species Program, celebrated Bat Week 2024 by planting native species of agave for bat habitat conservation as well as removing invasive buffelgrass from West Desert Trails.



Economic Impact

Freeport-McMoRan's Sierrita operations generated almost \$561 million in economic benefits for Arizona in 2023, which includes over \$336 million for Pima county.

The Sierrita operations employed 1,292 and the ripple effect of wages and taxes, plus services we purchased, created a total of 4,510 jobs in the state, generating additional economic benefits.

Resilience Plan Update

The Sahuarita/Green Valley Resilience Action Plan (RAP) will focus on identifying and mitigating community risks to ensure a sustainable future. The plan will adopt an offensive approach to address current economic challenges and buffer against risks. It emphasizes short-term actions based on available resources and local capacity.

- A resilience survey is underway to gather local insights with a site visit planned for January to kick off the mobilization team. Community members are encouraged to participate in the survey to voice perceived risks and contribute to the plan.
